TO WHOM SO EVER IT MAY CONCERN

The Institution of Fire engineers (India) established in the year 1973, had been conducting GRAD I Examination and awarding a certificate of Graduateship Examination (GRAD I Certificate) to the successful in service candidates for their career progression in terms of the approval accorded vide OM No. F-18-1.2/78-T.7/12 dated 30/04/1983 issued by the Ministry of Education and Culture. The said certificate of Graduateship Examination issued by IFE (India) was recognized as the requisite qualification for the purposes of recruitment to the superior posts and services under the Govt. i.e. the middle advisory cadre like Divisional in Officer/Assistant Divisional Officer and below.

The Govt. of India vide OM dated 06.12.2012, intimated that the recognition already granted to all the Technical Institutions including IFE (India) awarding pass certificates, being considered as equivalent to the requisite qualification required for recruitment / appointment and for promotion in the Govt. Department (Fire Services), will cease to exist w.e.f. 01/06/2013, till the curriculum of the same is duly reviewed by AICTE, the regulator for extension/renewal of the recognition already granted.

The operation of the above noted OM dated 06/12/2012 on being challenged was stayed by the Hon'ble High Court of Delhi, vide order dated 23/05/2013 passed in writ petition bearing W.P(C.) N.3239/2013 & CM Appl. 6125/2013. Where after the cases of other Institutions including IFE (India) W.P(C) No.6226/2013 were also tagged/linked by the Hon'ble Delhi High Court with the aforesaid writ petitions. The case challenging the OM dated 06/12/2012 by number of Institutions including IFE (India) is still pending in the Hon'ble High court for final disposal.

It is relevant to mention here that the stay granted by the Hon'ble High court was extended from time to time during the course of hearing. However, no fresh admissions are being made in terms of the directions dated 11/02/2020 passed in the bunch of writ petitions including the petition of IFE (India).

The aforesaid is for the information of one and all, especially those who are involved in the field of the Fire Engineering.

This to Ministry of Human Resource has reference Development (MHRD) Memorandum No.F.No.11-15/2011-AR(TS-11) dated 06.12.2012, where under it has been so intimated that the recognition already granted to the IFE (India) pass certificates issued, for being considered as equivalent to the requisite qualification required for recruitment / appointment and for promotion in the Govt. Department (Fire Services), will cease to exist w.e.f. 01/06/2013, till the curriculum of the same is duly reviewed by AICTE, the regulator for extension/renewal of the recognition already granted. The operation of the above noted letter on being challenged has been stayed by the Hon'ble High Court of Delhi, vide order dated 23/05/2013 passed in writ petition bearing W.P(C.) N.3239/2013 & CM Appl. 6125/2013 titled as IETE Vs U.O.I & Ors. and other similar institution including the IFE (India), WP (C)No. 6226/2013 The case is pending in the High Court of Delhi. As such, all the candidates seeking fresh admission in the IFE (India), after 01.06.2013, are to bear the above in mind and would be required to give an undertaking as under:

UNDERTAKING TO BE GIVEN BY THE CANDIDATE FOR SEEKING ADMISSION WITH IFE (INDIA) FOR GRAD-I EXAMINATION / CERTIFICATE
